Parking

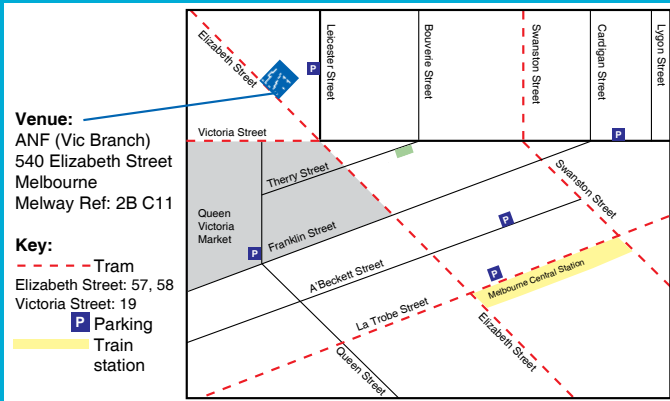
Secure all-day parking sites as shown on the map below.
